1. INTRODUCTION

The South African Local Government Association (SALGA) is a public entity established by the Organised Local Government Act (Act 52 of 1997) to assist in the comprehensive transformation of local government in South Africa. SALGA is managed within the framework of the Public Finance Management Act (Act 1 of 1999) and is listed as a schedule 3A public entity. Its main objectives are to:

- Represent, promote and protect the interests of local government;
- Transform local government to enable it to fulfil its developmental role;
- Enhance the role and status of its members as provincial representatives and consultative bodies of local government;
- Enhance the role and status of municipalities;
- Be recognised by national and provincial governments to be the representative and consultative body in respect of all matters concerning local government and to make representations to both provincial and national governments in respect of any matter concerning local government;
- Ensure the full participation of women in organised local government;
- Be the National Employers' Association representing all municipal members and, by agreement, associate members.

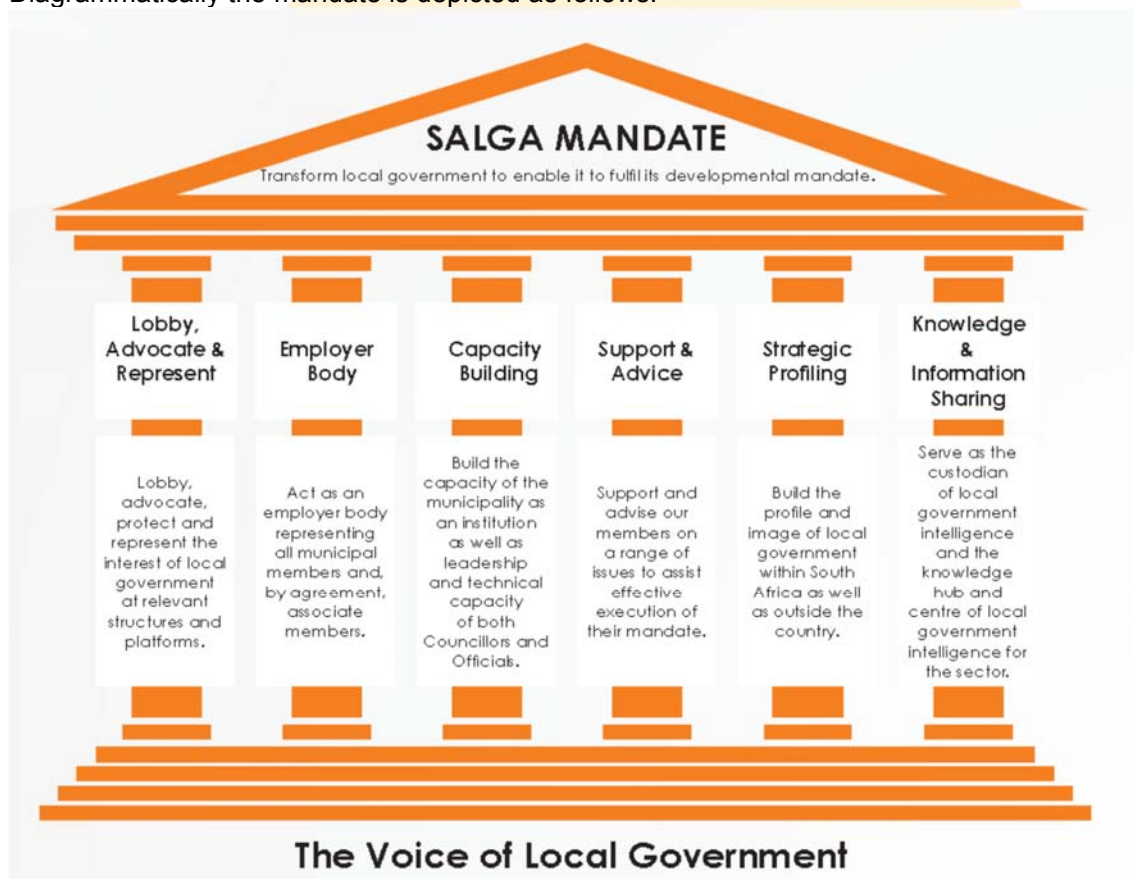
2. SALGA MANDATE

Developmental Local Government is an essential component of the machinery of government. In accordance with its constitutional mandate, SALGA is obliged to transform the local government sector to one that has the required capacity to make a meaningful contribution to poverty alleviation, economic development and all socio-economic opportunities that the state has geared itself to provide for its people. SALGA also serves as the representative voice of all 257 municipalities in the country. For the past 20 years, since its establishment, SALGA has endeavoured to bring focus to its mandate of supporting local government transformation in a complex environment, characterised by a highly diverse and diffuse membership-base of municipalities. In terms of its amended Constitution, SALGA is a unitary body that consists of a national association and nine provincial offices. Its mandate rests on six primary pillars:

- (1) **Representation, Advocacy and Lobbying** refers to representing the interests of members in legislatures and other policy making and oversight structures. It also refers to engaging with various stakeholders, public debates etc. in the interest of Local Government.
- (2) **Employer Body** refers to being an effective employer representative for members. Employer representation is carried out through collective bargaining (in terms of the Labour Relations Act) in various structures including but not limited to those established in the South African Local Government Bargaining Council.
- (3) **Capacity Building** refers to facilitating capacity building initiatives through among others; representing member interests in the Local Government Sector Education Authority (LGSETA). SALGA strives to facilitate a coherent, well-co-ordinated capacity building programme for municipal councillors and officials.

- (4) **Support and Advice** refers to the provision of tools and services that enable municipalities to understand and interpret trends, policies and legislation affecting Local Government and to implement the said policies and plans
- (5) **Strategic Profiling** of Local Government refers to enhancing the profile and image of local government as an important and credible agent for the delivery of services. Profiling focuses within South Africa, the African continent and the rest of the world.
- (6) **Knowledge and Information Sharing** refers to building and sharing a comprehensive hub of Local Government knowledge and intelligence that will enable informed delivery of other SALGA mandates. The knowledge hub is also a useful reference point for all who seek Local Government information.

3. PURPOSE OF THIS REQUEST

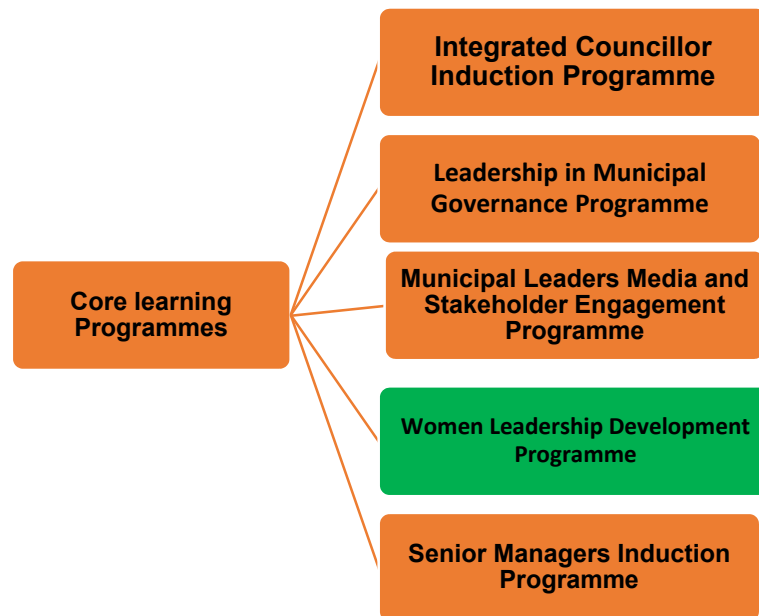
The purpose of this document is to call for proposals from LGSETA Accredited service providers to assist the South African Local Government Association (SALGA) with the development of an accredited Women Leadership Development Programme. The design and development of this accredited programme entails the review of existing policy frameworks advocating for the development of women (inclusive of the goals, terms of reference and programme of action of the SALGA Women Commission); desktop review of existing women development programmes and legislative amendments as per set accredited training protocols, development of a standardised learner guide (which is inclusive of portfolio of

evidence guide, facilitator guide, powerpoint presentation, assessment and moderation guide and the development of project related templates applicable to project management standards of programme implementation, monitoring and evaluation).

4. BACKGROUND AND PROGRAMME IMPLEMENTATION CONTEXT

The Local Government Capacity Building Funding Plan 2017/18 -2020/21 which was submitted to the LGSETA provides for, amongst others; the implementation of continuous development programmes under the auspices of the SCLG as outlined in the diagram below:

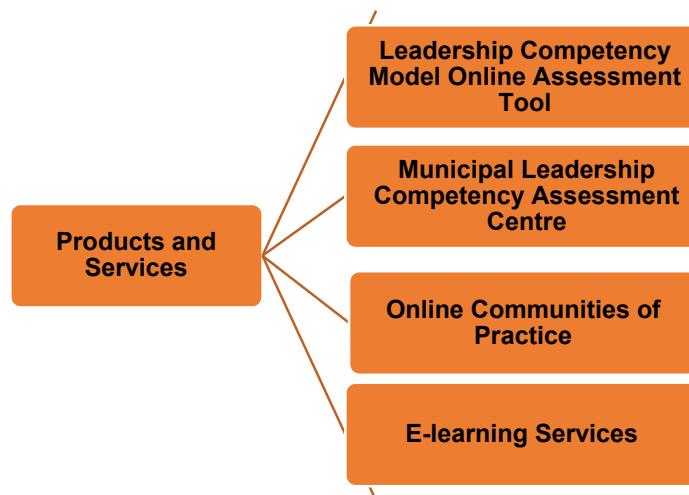
- **CORE PROGRAMMES:**

4.1. THE LOCAL GOVERNMENT WOMEN LEADERSHIP DEVELOPMENT PROGRAMME CONTEXT

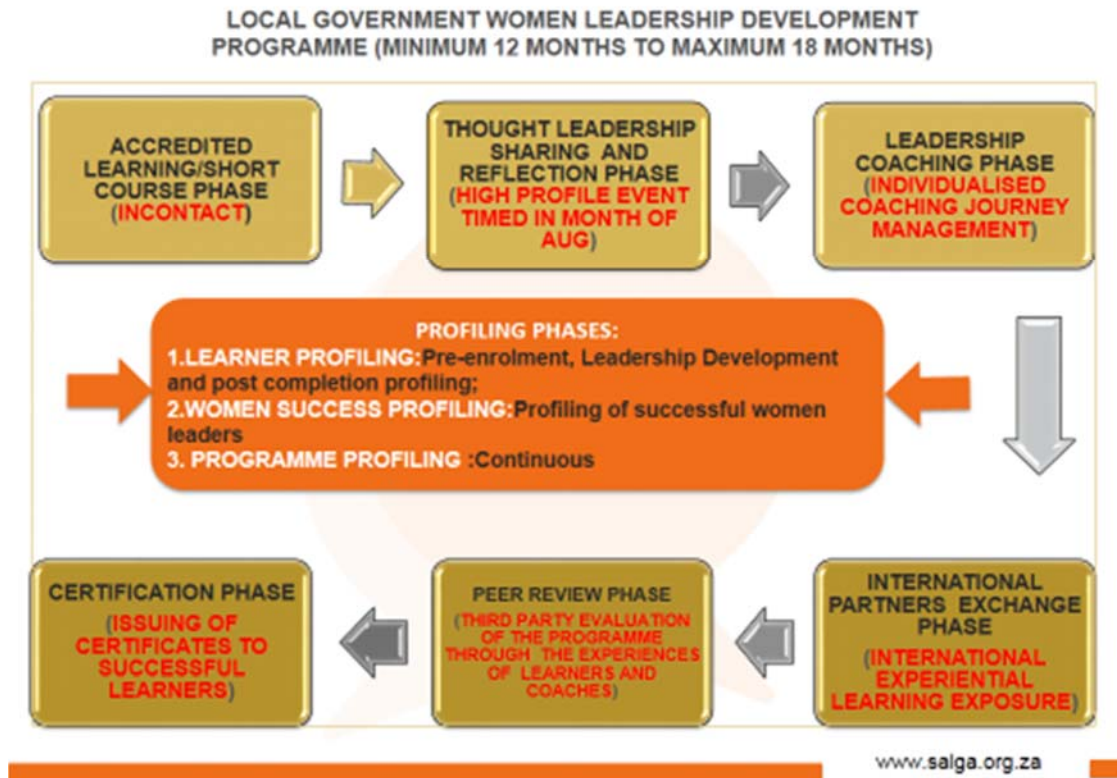
The Local Government Women Leadership Development Programme is a multi-purpose programme for women leaders and aspirant leaders in Local Government with specific focus on profiling and affirming good work done by women in leadership positions, mentoring and coaching of aspirant leaders as well as providing seminar styled network opportunities to build women leadership capacity leveraging on both public and private sector best practice.

This programme is targeted at women in municipal leadership roles as well as those who aspire to be future leaders, both councillors and municipal officials.

The objectives of the accredited Local Government Women Leadership Development Programme are:

- To empower women occupying leadership positions at political and administrative levels become effective leaders in their specific roles and in society;
- To prepare women aspirant (seeking to occupy leadership positions in future) leaders to take up their roles when appointed and/or assigned to leadership positions;
- To propel women leaders to the forefront of organisational change efforts geared at transforming municipalities into high performing organisations;
- To enhance women leadership capacity in local government;
- To enhance the profile of women leaders in local government;
- To institutionalise the SALGA leadership competency model as a cornerstone of leadership development in the sector;
- To promote diversity in leadership,
- To unleash leadership potential in women to build and sustain a pipeline of effective women leaders.

4.2. PROGRAMME DESIGN AND IMPLEMENTATION PHASES



4.2.1 LEARNER PROFILING PHASE

In 2016 SALGA under the auspices of the SALGA Centre for Leadership and Governance developed the SALGA Leadership Competency Model - as a response to drive leadership effectiveness in local government. The purpose of the model is to assist councillors and officials with identifying developmental areas in order to enhance their leadership and governance competencies. There are twelve competencies which have been clustered into four areas namely leading self, delivering service, engaging stakeholders and setting direction.

The model synthesises a large number of leadership theories and principles. Those that are particularly relevant to Local Government and included in the model includes: Transactional leadership, Transformative leadership, Servant leadership, Emotional Intelligence, Spiritual leadership, authentic leadership, Facilitative leadership, Sustainable leadership, Systems and Strategic thinking.

Delegates enrolled onto the Local Government Women Leadership Development Programme come from diverse backgrounds, have different areas of specialization, qualifications as well as different levels of work experiences and exposure within local government, they will be profiled in the beginning in order to assess their current skills and competencies as well as identify the leadership competencies gaps that they have in order to work towards filling them through participating in this programme. The profiling of women leaders will include a combination of personal attributes, capabilities and organisational support as supported/informed by SALGA Leadership Competency Model. The profiling of delegates will

be continuous throughout all the phases of the programme until delegates complete the programme.

4.2.2 ACCREDITED LEARNING/SHORT COURSE PHASE (INCONTACT)

The delegates will attend an accredited skills programme for the Women Leadership Development Programme, complete portfolios of evidence throughout the programme. The practical work experiential learning will exposure them to practical continuous learning, dedicated coaching which will support them in the completion of portfolio of evidence at the end of the programme. Upon successful completion will receive a certificate of competence.

It is SALGA's preference that this phase is undertaken through or in partnership/collaboration with a reputable institution of higher learning.

4.2.3 THOUGHT LEADERSHIP SHARING AND REFLECTION PHASE (HIGH PROFILE EVENT TIMED IN MONTH OF AUG)

A seminar will be convened during the month of August in order to coincide with the commemoration of Womens Day. The seminar topics will be a combination of thought leadership and will allow delegates enrolled onto the programme to share and reflect on their leadership experiences.

4.2.4 LEADERSHIP COACHING PHASE (INDIVIDUALISED COACHING JOURNEY MANAGEMENT)

This phase entails putting enrolled delegates into a customized coaching and mentorship segment of the programme that is individualized based on each female leader's profile. The delegates will be paired/matched and allocated to established coaches/mentors that will support them in their learning journey till the end of the programme.

4.2.5 INTERNATIONAL PARTNERS EXCHANGE PHASE (INTERNATIONAL EXPERIENTIAL LEARNING EXPOSURE)

As part of ensuring that the delegates enrolled onto this programme are exposed to various learning scenarios, an international experiential programme will be developed and implemented through one of SALGA's strategic international partners. The aim of this segment of the programme is to ensure that learners receive an experiential professional development opportunity in a selected environment/s of notable best practice.

4.2.6 PEER REVIEW PHASE (THIRD PARTY EVALUATION OF THE PROGRAMME THROUGH THE EXPERIENCES OF LEARNERS AND COACHES)

This phase entails coaches and delegates evaluating one another in terms of the learning journey and lessons learnt and how best the programme can be enhanced.

4.2.7 CERTIFICATION PHASE (ISSUING OF CERTIFICATES TO SUCCESSFUL LEARNERS)

This phase is about conducting assessments, moderations, and verifications of delegate portfolios of evidence submitted by the delegates enrolled onto the programme upon successful completion of the programme. Uploading learner results on the SALGA LMS will be done in a manner that is compatible with the SETA requirements.

5. SCOPE OF WORK

SALGA intends to appoint a suitably qualified and competent accredited bidder to assist with the following services:

A. REVIEW OF THE CURRENT CONTENT AND AMENDMENTS (LEGISLATION/SYSTEMS/PROCESSES):

- Review the current content in line with all legislation enacted and policy changes made to date applicable to women leadership in local government.
- Engage relevant stakeholders to solicit their inputs during the review and final draft.
- Produce Final Draft for sign off and related documents.

B. ALIGNMENT AND LAYOUT OF THE ACCREDITED PROGRAMME WITH RELEVANT LGSETA UNIT STANDARDS:

In the main, this material should be aligned to relevant unit standards accredited by the LGSETA. A further detailed enquiry needs to be undertaken of all other applicable unit standards that require integration into the material development process.

C. DESIGN AND DEVELOPMENT OF AN ACCREDITED WOMEN LEADERSHIP DEVELOPMENT SKILLS PROGRAMME

Materials development must account for all areas of learning related to the development of women leaders within local government.

D. DEVELOP A STANDARDISED LEARNER GUIDE, PORTFOLIO OF EVIDENCE, FACILITATOR GUIDE, POWERPOINT PRESENTATION, ASSESSMENT, MODERATION, VERIFICATION AND THE DEVELOPMENT OF PROJECT RELATED TEMPLATES FOR PROGRAMME IMPLEMENTATION, MONITORING AND EVALUATION.

E. ARTICULATION OF A DELIVERY MODEL

The delivery model must clearly articulate a blended learning approach which includes classroom based and/or online learning methodologies.

F. DEVELOP AND ADMINISTER/FACILITATE TRAIN THE TRAINER PROGRAMME FOR THE FACILITATOR COHORT

The development/administration of the training the trainer programme for the facilitator cohort will prepare them for their facilitation role which will be discharged during the rollout of the Local Government Women Leadership Development Programme is the final phase of the development process before the programme is rolled out. This phase will be preceded by a formal launch of the programme which will be coordinated and delivered by the SALGA in-house Marketing and Communications team.

G. IMPLEMENT THE NATIONAL ROLL OUT OF THE ACCREDITED WOMEN LEADERSHIP DEVELOPMENT TRAINING PROGRAMME:

- Provide project management services to SALGA on the roll out of the accredited Performance Management Training Programme whilst ensuring that the programme gains insight and develops capacity to manage the project.
- Develop project related templates for programme implementation, monitoring and evaluation across the project value chain.
- Portfolio of Evidence distribution, collection, Assessments, Moderation, Verification, loading of results on the National Learner Database and conduct site visits to facilitation sites.
- Provide continuous learner support to ensure learners are certified as competent upon successful completion of the programme.

- Upload learner results onto the LGSETA system.
- Issuing of Statements of results (SORs) and certificates of competent and attendance for delegates.
- Submission of a final project close out report.

5.1 BIDDER REQUIREMENTS

The bidder will be expected to demonstrate technical ability and capacity to undertake an assignment of this complexity.

The successful training provider must fulfil the following requirements:

- a) Attend a compulsory briefing at a time to be advertised on the advert.
- b) Shortlisted bidders will be required to make a presentation to SALGA on their value proposition;
- c) Produce an accreditation certificate with the Local Government Sector Education and Training Authority (LGSETA) that is valid and in good standing;
- d) Produce accreditation for the specific training programmes that are relevant to the scope of the requirements of the Local Government Women Leadership Development Programme;
- e) Have sound knowledge of the local government sector and the capacity building landscape coupled to legislation governing skills development e.g. NSDSIII, National Qualifications Framework, Qualifications Authority Act, Public Finance Management Act & Skills Development Act etc.)
- f) A proven written track record for managing projects of a comparative size and nature accompanied by 3 contactable references;
- g) A proven written track record in materials development for accredited programmes, facilitation, assessment, moderation, verification and certification of learners;
- h) The bidder must demonstrate capacity and experience for enrolling sizeable number of delegates on a decentralised basis;
- i) In respect of assessors and moderators to be used in the programme, the training provider must submit their registration documents, qualification and experience;
- j) In order for SALGA to be assured that the bidder is able to secure the registered assessors and moderators for this project, the bidder must produce proof of signed SLAs between it and the registered assessors and moderators.
- k) Demonstrate capacity for delegate and logistics management
- l) The training provider must have a Learner Management System that is compatible to SETA requirements;
- m) The training provider must show proof of uploads of learner achievements from past projects;
- n) A detailed project management plan that outlines the details of all the elements of the programme from development and rollout through to certification;
- o) As part of the proposal the training provider must demonstrate the understanding of the implementation of the training programme of this magnitude by outlining the following details amongst others;
 - a detailed rollout plan across the country in an efficient, effective and cost effective manner;
 - A project plan reflecting the scheduling, organisation and resource mobilisation that will match the project of this magnitude;
- p) The bidder must have an administrative capacity, including office space, equipment and personnel that is commensurate with delivery of a large project. To this end SALGA will reserve the right to conduct a site inspection of the premises of the Training Provider.
- q) The bidder must provide a detailed project budget breakdown for Assessments, Moderation and Verification of learner portfolio of evidence.

5.2. BIDDER COMPETENCIES

SALGA wishes to engage the successful bidder with demonstrated appropriate skills/expertise in the following areas:

- Project management and administration of projects of a comparative size and nature
- Stakeholder engagement and learner support pedigree or proven experience.
- Project risks identifications and management
- Conducting assessments, moderations, verifications of delegate portfolios of evidence
- Uploading learner results on the SALGA LMS in a manner that is compatible with the SETA requirements
- Continuous reporting on the project

5.3. CONTENT OF PROPOSAL

(Information to be submitted by the bidders)

The proposal should include

- 5.3.1. all relevant perceived strengths and weaknesses of the firm bidding for the service, e.g. similar previous experience, in-house skills, etc; providing information which will assist SALGA to assess its capabilities, competitive advantages, etc.;
- 5.3.2. the summary of the bidder's mission statement, the vision statement, values and long term strategies and objectives as comprehensively as possible;
- 5.3.3. a list of references of previous and current appointments relevant to the required services; examples of such services capabilities and experience and more specifically the number and size of organisations where service rendered in specific sectors in government and areas of expertise.
- 5.3.4. an organogram or list of partners, managers, specialists, together with the *curriculum vitae* of the staff who will be available for the duration of the work; any staff changes regarding staff allocated to SALGA must be done in consultation with the Project Manager representing the organisation. The successful bidder should provide experienced specialists relevant to the required services.
- 5.3.5. A breakdown of the project costs VAT inclusive, per category as required for services rendered. Expenditure incurred without the prior approval of SALGA will not be reimbursed. An analysis of costs must be given to cover the full amount, and where possible, costs should be linked with specific tasks to be undertaken. All other incidental costs should be included in the budget breakdown.

- 5.3.6. In so far as is possible, a comprehensive budget, showing the service of activities proposed, with charge-out rates and budgeted hours per activity, detailing all assumptions made in arriving at a proposed budget, including all cost factors such as traveling.
- 5.3.7. How the bidder proposes to provide governance assistance to SALGA; and
- 5.3.8. In so far as is possible, provide an overview of the methodology to be applied.
- 5.3.9. How the bidder will ensure that there is transfer of skills to the SALGA team.

5.4 APPOINTMENT, COMMENCEMENT AND DURATION

The appointed bidder is anticipated to commence the work upon appointment for a duration of **36 months** and end on the completion of the project.

5.5. DESCRIPTION AND EXTENT OF WORK (PROJECT MANAGEMENT)

5.5.1. Performing of assignments

Assignments are to be performed in accordance with the industry/profession standards as well as the terms of reference. All reports will be reviewed by the relevant Project Manager representing the organisation.

All working papers and reports and documents will become the property of SALGA.

The successful bidder shall work with the Directorate of SALGA on the planning of various phases of the service activities, and must be prepared to regularly report the progress to the relevant Project Manager.

5.5.2 Timing of assignments

The performance of this assignment shall be in accordance with the approved plan by the Project Committee. The final responsibility of approving the scope and extent of the work resides with the relevant Project Manager.

5.5.3 Quality assurance reviews of the work

The bidder shall ensure that all work conforms to the required SETA quality assurance standards

5.5.4 Monitoring progress of assignments

On a mutually agreed basis, the bidder shall meet with the Project Manager to report progress of the work, and at the Project Committee meetings.

5.5.5 Payments

SALGA undertakes to pay out within a reasonable time period all valid claims for work done to its satisfaction upon presentation of a substantiated claim. No payment will be made on outstanding information not submitted by the bidder.

The parties shall, upon appointment of the bidder, sign a service level agreement to govern their business relationship.

Acceptance of any bid does not mean that work on an uninterrupted basis is guaranteed for the duration of the contract.

5.5.6 Expenditure incurred by the bidder

The SALGA will not be held responsible for any costs incurred by the bidder in the preparation and submission of the bid.

6. INSTRUCTION TO BIDDERS

6.1 General Instructions

This document constitutes a Request for Proposal (RFP), which specifies SALGA's requirements for an LGSETA accredited bidder to Develop and implement a Local Government Women Leadership Development Programme on behalf of SALGA. The information contained herein provides a format to facilitate bidder's responses to this RFP. It is important that the format be followed closely to help maintain the decision making timetable. Responses must be presented in the same order as the requirements appear, section by section, and numbered accordingly, with acknowledgement of all clauses. All pricing information should be fully disclosed with all charges clearly defined, i.e. a per unit fee based on activity. Please feel free to address any other potential services not specifically mentioned in this RFP that may be of benefit to the National Executive Committee (NEC) of SALGA which is the organisation's accounting authority.

6.2 Objectives

SALGA's objective in the call for proposals is to select a bidder accredited with LGSETA to to Develop and implement a Local Government Women Leadership Development Programme on behalf of SALGA.

6.3 Terms of Contract

The term of the contract shall be regulated by the Service Level Agreement (SLA) to be concluded with the winning bidder. It is anticipated that the term of the contract shall be for the duration of the assignment and shall expire upon fulfilment of the scope of work. The contract may be extended by mutual agreement. Thirty (30) days written notice must be given if either party wishes to terminate the agreement prior to the contract's expiry date.

6.4 Questions during Proposal Process

All such changes should be covered by the bidder's proposal. Information used

in the preparation of a proposal from other than this RFP and any written addenda (considered as the proposal documents) will not be considered as valid or official.

No further addenda will be issued by SALGA after 12:00 noon, four business days prior to RFP closing without providing an extension of time.

6.4 Submission of Proposal

SALGA reserves the right to accept any proposal submitted, or reject all proposals.

Any proposal submitted, that is not in complete compliance with the requirements of the proposal documents may be accepted or disqualified, at the option of SALGA.

Please outline in your proposal the assistance your institution is prepared to provide in order to meet the estimated contract duration period for the full implementation of the scope of work.

7.7 Termination of Contract

SALGA reserves the right to terminate the agreement with 30 days written notice to the winning bidder subject to the following:

- 7.7.1 the winning bidder fails to perform in accordance with the specified service requirements as set out in the RFP;
- 7.7.2 the winning bidder fails to provide project deliverables as defined under **part** Error! Reference source not found.**above** without written explanation;
- 7.7.3 the winning bidder otherwise violates the provisions of the RFP to a substantial degree.

7.8 Liability

SALGA will not be held liable for any actions of the winning bidder and/or its employees.

8 CONDITIONS OF BID (FAILURE TO MEET ANY OF THE REQUIREMENTS BELOW MAY RENDER YOUR BID PROPOSAL NON-RESPONSIVE)

- 8.1. The requirement for content of the project proposal section below outlines the information that must be included in bid offers. **Failure to provide all or part of the information may result in your bid being excluded from the evaluation process.**
- 8.2. A contract will be signed with the appointed Bidder.
- 8.3. The Bidder will be required to sign confidentiality and indemnity agreements with SALGA.
- 8.4. SALGA may at its own discretion vary an instruction to include more work.
- 8.5. Failure to comply with any condition of this request for a proposal will invalidate respective tender proposal
- 8.6. In the event that any conflict of interest is discovered during the assignment, SALGA reserves the right to summarily cancel the agreement and demand that all the information, documents and property of SALGA be returned forthwith.
- 8.7. SALGA reserves the right to request new or additional information regarding each bidder and any individual or other persons associated with its project proposal.
- 8.8. Bidders shall not make available or disclose details pertaining to their project proposal with anyone not specifically involved, unless authorized to do so by SALGA.
- 8.9. Bidders shall not issue any press release, social media or other public announcement pertaining to the details of their project without the prior written approval of SALGA.
- 8.10. Bidders are required to declare any conflict of interest they may have in the transaction for which the bid is submitted or any potential conflict of interest. SALGA reserves the right not to consider further any bid where such a conflict of interest exists or where such potential conflict of interest may arise.
- 8.11. The bid offers and proposals should be valid and open for acceptance by SALGA for a period of 120 days from the date of submission.

- 8.12. Bidders are advised that submission of a project proposal gives rise to no contractual obligations on the part of SALGA.
- 8.13. Disputes that may arise between SALGA and a bidder must be settled by means of mutual consultation, mediation (with or without legal representation) or, when unsuccessful, in a South African court of law.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
